MINUTES OF THE HOUSTON COUNTY COMMISSION REGULAR SESSION April 14, 2025

PRESENT: Chairman Brandon Shoupe, Commissioner Curtis Harvey, Commissioner Tracy Adams, Commissioner Ricky Herring, Commissioner James Ivey, County Engineer Barkley Kirkland, Chief Administrative Officer Peter Covert and County Attorney Pres Register.

Chairman Shoupe called the 10:00 a.m. meeting to order and welcomed everyone to the April 29, 2025 Houston County Commission Regular Session and declared a quorum as all commissioners were in attendance.

The invocation was given by Pastor Taylor Rutland, from First Baptist Church of Dothan, and the pledge of allegiance was led by Commissioner James Ivey.

The minutes of the previous meeting were approved on a motion by Commissioner Herring and seconded by Commissioner Adams. The motion carried unanimously.

Chairman Shoupe announced that today was Assistant County Engineer Tyler Reeder's birthday and wished him a Happy Birthday.

# **AWARDS AND PRESENTATIONS**

1. Recognition – Junior ROTC Cadets – Commissioner Tracy Adams

Chairman Shoupe began by thanking Commissioner Adams for bringing this to the commission as it is an honor to have these outstanding young people in attendance today.

Commissioner Adams approached the podium and asked the cadet to come forward. He began by saying that this is an opportunity for the commission to see some of the most impressive people they will meet and this is their day. He then thanked the Rehobeth Mayor, Kimberly Trotter, for being in attendance to see the outstanding cadet from Rehobeth High School. Commissioner Adams then presented an Appreciation Certificate to Cadet Lt. Commander Jazmine Coyt, from Rehobeth High School.

Ms. Coyt said that she was very grateful for this award and especially the ROTC program as it has helped her to overcome a lot of controversies and problems with personal and life.
