1. Request from the Personnel Board to concur with the 2026 County Holiday Schedule – Sheri Garner, Personnel Director

6. Request to approve resolution for MPO Project for the resurfacing of N. Broadway St. from HWY 84 to Main St. – Road & Bridge

8. Request from the Town of Rehobeth and Houston County Schools to assist with water drainage deficiency affecting Rehobeth Elementary School and the Rehobeth walking trail – Road & Bridge

Commissioner Herring made a motion to approve the request from the Town of Rehobeth and Houston County Schools. Commissioner Ivey seconded the motion and with there being no questions or discussion, the motion carried unanimously.

Chief Administrative Officer – No report

County Engineer – 3 closed roads: Cumbie, Bill Yance, and Prevatt. Engineer Kirkland stated that there are 7 roads they plan to pave this summer, with weather permitting. Those roads include County Line Road, Power Dam Road, Prevatt Road, D Hodge Road, Ben Ivey, Iris and Donnie Mae. He added that there are 3 more scheduled for this coming fall and those include Bill Yance, Furnie Folks and Cumbie.
