MINUTES OF THE HOUSTON COUNTY COMMISSION REGULAR SESSION June 23, 2025

PRESENT: Chairman Brandon Shoupe, Commissioner Curtis Harvey, Commissioner Tracy Adams, Commissioner Ricky Herring, Commissioner James Ivey, County Engineer Barkley Kirkland, Chief Administrative Officer Peter Covert and County Attorney Pres Register.

Commissioner Adams began by announcing that a fireworks show will be held at Dupree School on July 4th and the gates open at 4:30 p.m.

Commissioner Herring announced that the annual Rehobeth Red, White and Boom event will be held on Saturday, June 28th with events beginning at 3:00 p.m. He encouraged everyone to attend as there will be fireworks, music and good fellowship.
