MINUTES OF THE HOUSTON COUNTY COMMISSION REGULAR SESSION July 14, 2025

PRESENT: Chairman Brandon Shoupe, Commissioner Curtis Harvey, Commissioner Tracy Adams, Commissioner Ricky Herring, Commissioner James Ivey, Asst. County Engineer Tyler Reeder, Chief Administrative Officer Peter Covert and County Attorney Pres Register.

Chairman Shoupe called the 10:00 a.m. meeting to order and welcomed everyone to the July 14, 2025, Houston County Commission Regular Session and declared a quorum as all commissioners were in attendance.

The invocation was given by Pastor Justin Kirkland from Mt. Gilead Baptist Church and the pledge of allegiance was led by Commissioner Tracy Adams.

The minutes of the previous meeting were approved on a motion by Commissioner Herring and seconded by Commissioner Ivey. The motion carried unanimously.

ANNOUNCEMENTS AND COMMENTS FROM THE CHAIRMAN AND COMMISSIONERS

Chairman Shoupe began by announcing that in District 4, the Wicksburg 10U and 12U All-star Baseball teams won their state tournaments and they will both be heading to the World Series in the very near future. In addition, the Dothan Dragons Soccer Team has advanced to the playoffs which will begin on Friday and will be held at Rip Hewes Stadium. The City of Dothan is hosting the playoffs this year with two games being held on Friday and then the championship game to be held on Sunday. The Dothan Dragons are the number eight team in the nation, in their league, and the number one team in the nation is their rival from North Carolina and they will be in the playoffs this weekend as well. Chairman Shoupe stated that he attended the press conference last week and the Dragons are determined to win a National Championship. He also reported that beginning in 2027 they will have a premier soccer league that will compete with MLS. With this, Dothan could potentially have a major league team if they continue to win.

Commissioner Herring made a motion to change the wording on item #10 and Commissioner Harvey seconded. The motion to change the wording passed unanimously.

Commissioner Herring then made a motion to approve the request to declare as surplus and donate the following vehicles to the Houston County Volunteer Fire Departments:
