Conversion. The tax assessor shall then base the appraisal on the then current market value assessing such property accordingly for the purpose of collecting and additional taxes due thereon.

After conversion, additional taxes will be due based on the sales price or the fair and reasonable market value of such property at the time of its conversion, whichever is greater, for the preceding three ad valorem tax years. If any property for which a current use valuation has been granted changes owners, the valuation will come off and the new owner will need to submit a new application.
